He was in the Revolutionary War. He enlisted in the Army at Lynches Ferry, VA in 1777. Joel & Elizabeth Gillenwaters lived 2 miles from the Ferry at that time & Joel knew James Simmons then. James Simmons was discharged in 1780. Hawkins County, TN "Distant Crossroads" April 1992 published a copy of a letter from John Baldwin, El Paso, TX. Rogersville, TN January 18, 1821 which was a petition to the Secretary of War concerning James' Revolutionary War Pension being discontinued as he owned 100 acres of land. The petition states only 25 acres are tillable and in poor condition and could not even be rented for enough to support this frail, ailing old man. He has no one living to assist in his support. He fought with General Waynes and talks of that celebrated General's hardest fought battles.

There were many signers to the petition, some of whom were, Thomas Gillenwaters, Joel Gillenwaters, JP, S. Wilson, T.J. Gillenwaters, Robert Brice, David Gillenwaters, Elijah C Gillenwaters. W. T. Gillenwaters. His grandson, William A Simmons of Hawkins County, TN, stated James was from North Carolina.(I have a copy of this petition) Census records of Hawkins Cty state he was born in Virginia. At age 91, James wrote his will on Jul 17, 1847. It was filed in May 1851 in Hawkins County, TN & witnessed by William and George A Gillenwaters. On the 1850 US Census for Hawkins County, TN, James has the following people living with him: Alice b c1810; Mary b c1832; Louisianna b c1835.

There is a biographical sketch of William A. Simmons, born May 10, 1843 in Hawkins Co., TN. His father is identified as James G. Simmons, born 1801, who married Sallie Gillenwater, no date given. In the Civil War, William A. Simmons (born 1843) enlisted first in Company G, Ninth Kentucky Infantry, then (1863) served in Company C, Thirty-Seventh Kentucky Mounted Infantry. Rogersviffe Tennessee January 18th, 1821 Dear Sir

At the request of Mr James Simmons, late a Revolutionary pensioner I am forwarding a petition signed.... by a number of his respectable neighbors, with aff of whom I believe you are acquainted. It is intended for the inspection of the Honorable Secretary of War. And it is in the nature of additioal proof with respect to the ofd man's condition in life and indigent Circumstances. The Secretary has discontinued him on the list on account of (it is presumed S.) his owning about 100 Acres of Land which in a comparative Point of viewing might be deemed sufficient to support the old man and Mr. Cafhoun, under that impression, no doubt, acted properly in discontinuing his pension.

I was present when Mr Simmons was examinedd in Court with respect to the vafue of his land and upon being interrogated by said court, replied that he would not be willing to take less than what the sum which is affixed to it in his Schedufe annexed to his Decfaration, but aftho he Spoke this conscientiously, and the Court has fixed accordingly, yet no person in the Courty would be willingg to give him more than half that sum in cash, and was it rented out, it would contribute but little to his support. As you wiff perceive from this certificate, and as the old man has no person on whom he can depend to work it. he must [seek assistance] from some quarter. On [Referring] to his original Decfaration filed in the War Departmen, wiff be found James Simmons version of General Waynes luck. & I now must mention, Sofdier's having been in some, if ot aff, of that cerebrated General's hardest fought battfes [.....] & I assure You Sir, I felt for this old mans Situation & upon my handing the notification of Mr Edwards answering to the old man his being discontinued when I [witnessed] him burst into a flood of tears at is forlom & destitute condition. He said he had hoped his Country would continue to extend to him benevofent and charitable aid during the final years he yet had to live and he had been taught to expect. But that he still hoped the Honorable Secretary of War upon Reconsideration of his [further testimony] would restore him. I observed to him that in case Of further disability (which he is fiable to every day on account of

age & infirmity, his own County would interpose its assistance and rescue him from total misery & want and advised him to submit in Silence. But he persisted in saying he would "try again' through You to recover that which his hard serious situation in life so Eminently Entitled him to Receive. And since then I have seen a fetter addressed to Your Speaker, I think, on the subject of Rev. Pen. in which the Secretary says that in one instance he continued a Pensioner whose amount of property exceeded \$300 Mr Simmons amounts only to \$290.58 & his land only to \$150.

Shoufd Mr. Calhoun think proper to reconsider his Case & Restore his Pension, this much I wiff say for old Mr Sinmons that not a more worthy meritorious sofdier of the Revolttion has been continued and none who deserves it better. Of his 100 acres but 25 is capable of being cuftivated and You knowing by leasing that out, it would not support hi,, -better for him had he given it away, if the possession of it should be the means of depriving him of his pension.

Rogersville as well as Washingtom City has not escaped the prevailing sickness. A number of your intimate friends have been and some yet are near the Gates of Death, among this latter are Docr Carden &Lady - Rob' Grimbell. MR. Graves friends are clearly looking for his Exit, all hopes have vanished of his Recovery now. Yet he has lingerd longer than was first expected.

We the undersigned being well acquainted with James Simmons of the County of Hawkins in the State of Tennessee late a Revolutionary pensioner but lately stricken off of the Roffs by the Honrable the Secretary of War on Account of the said James Simmons owning one hundred acres of land Do hereby Certify that said land is of the most inferior quality; there being also of that quantity not more than twenty five acres that is tiffabfe and that very much worn out and aff under bad fence, and the improvements on it not of much value, that said Simmons is very frail & feeble, afflicted with pain which disable him from supporting himself and furthermore believe that if any Revolutionary Soldier is entitled to, or deserves a Pension, the said James Simmons is one of that number on account of his Situation in life, as weff as on account of his Service.

Given under our hands this 1st day of January 1821.
