9/26/1989 Father Billy Bowie died: *at distribution- Trust= \$193K, Emma= \$475K*

8/1992 Mother Emma Bowie moved from Augusta to Clarksville

3/13/02 Emma into Johnson Regional MedCenter, AFB overnight with her

3/14/02 with sister Connie B Limbird review Emma's will and discuss how to deal with her decline .

3/19/02 Emma discharge from JPMC.

4/2/02 Arthur review Emma affairs with Eldercare Attorney

4/23/02 Emma signed DPOA

10/31/03 Dr Dunham diagnosis HTN, dementia.

4/15/04 Dr Dunham diagnosed Alzheimer's & irregular heartbeat,

4/15/04 Changed Edward Jones Account to sole owner, transfer on death. CBL and Emma signed

8/16/04 Dr Dunham, Do not drive order for Emma.

9/3/04 Emma driver license revoked.

10/19/04 Emma CVA at her apartment in Clarksville

10/21/04 begin shutdown of Emma's apartment

11/9/04 Arthur and JoAnne transport Emma to Ozark Nursing , CBL crying

12/17/04 Joseph graduated SMSU

12/19/04 Peggy Ayers, JoAnne's mother died

12/28/04 -12/29/04 Begin Removing furniture from Emma apt, took her checkbook away from CBL

1/3 -1/7/05 tough days with CBL emptying apt, wire funds to Edward Jones because of CBL thief

1/10/05 Closed Emma's apartment in Clarksville.

1/21/05 Limbird petition for guardian of person & estate filed, assigned Judge McCain

2/3/05 Closed Emma bank account in Clarksville, all finances now with Edward Jones.

2/5/05 Notify Limbird plan to move Emma from Ozark to Rogers. 2/8. *both nursing agree OK to move.*

2/7/05 Limbird swears emergency (perjury # 1) and is granted temporary guardian by Judge Sutterfield

2/8/05 ONH administrator notify me of Temporary Guardianship order.

Mom chest pain and into hospital later that afternoon.

ONH nurse later told me that Emma was upset by conflict between Limbird and me.

2/10/05 I filed notice opposing at Court House in Ozark, rec'd summons dated 1/21/05 that afternoon.

2/14/05 Mainard motion to dismiss

2/15/05 Wilson letter states concerned that her mother might be moved..

4/5/05 Guardianship hearing in Ozark. *(perjury # 2, return to apartment)* Sutterfield splits guardian of person from estate.

6/16/05 I receive and accept letter of guardian of estate.

1/17/06 Hearing and denial of Motion to Compel release of information.

1/23/06 Mainard's father died after extended illness.

3/3 -3/14/06 Exchanged letters with Limbird regarding final arrangements

8/1/06 Hearing Petition for Declarative Judgment of Wards Remains upon death.

(perjury # 3 - burial contract in place), decision: not ripe, wait until death

8/23/06 Limbird signed burial contract as "guardian of Emma" "I have the legal right to arrange"

(Malfeasance/fraud/contempt of whole guardianship process)

10/2/06 Judge Sutterfield signs order.

5/18/07 Mainard son convicted of murder 2, sentenced 18 years.

6/12/07 Completed and mailed 2nd annual guardian report.

9/4/07, Tuesday, about 7PM found message from Limbird on JoAnne's answering machine

"you may come to memorial service for our Mother tomorrow in Augusta."

ONH refused to tell me anything per written instruction from Limbird.

Called Rhodes in Augusta, and Limbird, neither called back, ever. Telcon Mainard.

ONH call back with news that Emma died that morning, Shaffer took body.

Called Shaffer and hear that Rhodes called that morning and picked up body.

9/5/07 Wednesday, Rhodes reports Mom was buried 5:15 PM yesterday, *the same day she died.*

The lawyer working with me as guardian of my mother has told me a couple of times that the events surrounding my mother's death and burial are the reason Arkansas has an "outrage" law. Limbird's actions make the most complete case of "Outrage" that he has ever seen. There were so many things wrong with the three years of "Guardianship", in effect the whole process was malicious and overwhelming, I still cannot make a concise summary. Topics that I have discussed with the guardian lawyer --fraud, contempt of court, multiple perjury, theft, deception, and malfeasance.

My mother had a stroke on top of Alzheimer's Disease in October 2004 and she ended up in a nursing home in Ozark. My sister lived near Mom and had difficulty dealing with Mom's problems from early on. I've never been very close to the sister, viewed her as eccentric and controlling, but had never realized the extent of her troubles. An uncle who was a director at Ozark Guidance Center, commented that he believes she is "mentally distributed.."

The most outrageous string of events had to do with the way Limbird hid news about Mom's death and burial from me.

About a year before Mom died, I tried to make final arrangements for her, as DPOA, executor, and Guardian of Estate. Series: letters, court hearing and order, contract fraud, silence about contract nearly a year, instruct nursing home not to tell me, embalmed and buried on day of death.

Limbird perjured herself on in at least three court appearances, deceitfully entered contract as guardian with malice towards me.still fighting my effort to settle estate. taunting continues.

I managed Mom's finances after Dad died. In those 18 years, I had built her up to over 2 million dollars, it really bothers me that given Limbird's actions that she has benefited so much by my efforts for Mom... Over one million dollars into her pocket...that should have been used for Mom's comfort and benefit...
