Orphan's Court Minutes 4, page 544:

Regular Orphans Court, April 25, 1842

Ordered that Benjamin W Saxon, Executer of the estate of Eli Terry, Dec'd, have leave to sell sufficient property to pay the debts of said estate. Ordered to make a return of said sale within three months.

Ordered that the report of Benjamin W Saxon, Administrator of the Estate of Walter L Terry, Deceased and Executor of the Estate of Eli Terry Deceased copy of the copartnership business in and about gmill be received and recorded.

Special Orphans Court, July 11, 1842

Orphan's Court Minutes 5 page 157: Special Orphans Court, July 10, 1843

David Rodgers and Benjm W Saxon vs. Ad quod damnum Their Neighbors

Whereas application has been heretofore made to the clerk of this court by David Rodgers and Benjm W Saxon for a writ of Ad quod-damum in order to obtain leave to establish a saw and grist mill on Mortar creek on the East half of the South East quarter of section twenty nine in Township Nineteen Range Seventeen and a writ having issued to the sheriff as directed by the statute and returnable this day and agruable to the command of said writ, a jury was summoned, impanneled and sworn by Moses Clepper Sherriff of said county and said jury returned the following inquest.

State of Alabama, Autauga County.

We the undersigned being called on to act as a jury to investigate the place where Mr David Rodgers, Benjm W Saxon, and William? Bailey wish to build a saw and grist mill. after our examination of the primises pointed out in a writ applied for by them, we do grant the said applicants the priviledge to build the said mill on the following numbers of land towit. East 1/2 of South East 1/4 of Section 29 T19 Range 17. Property of said Rodgers, Saxon and Bailey in as much as we believe the establishment of said mill will not be to the injury of any person- and do grant said applicants to raise of head of water of six feet in height.

And there appearing to be no objection to the erection of said mills, It was by the court Ordered that said David Rodges and B.W.Saxon have leave to erect said mills Henly Brown JCC
