After my death, I direct , in this my last will and testament, the disposition of my property as follows, viz:-- To my children Louise, Thomas and Joe, I give and bequeath five dollars each.

To my wife Laura Stanley charged with payment of above named amounts and all my legal obligations - I give devise and bequeath absolutely, all my estate, real, personal and mixed, chases? in action & ch-? of which I may die seized and possessed or to which I may be entitled at time of my death.

In witness whereof I have hereto set my hand this 7th, day of November 1896.
